

## *Placement Contract*

**Westmeadow Labradors** occasionally finds that it is advantageous to place certain “***pick***” puppies with individual homes. This can be a twofold benefit to the puppy/dog, as well as to prospective puppy owners.

Firstly, the puppy/dog has the benefit of growing to its full emotional and physical potential within a family environment. Also, the prospective foster family has the opportunity of obtaining a “***pick of the litter puppy***” at no initial financial expenditure.

1. The puppy/dog will be placed with the foster family at no financial cost. The puppy/dog remains the property of Brent Spurr on the registration papers.
2. The puppy and annual vaccinations will be borne by Westmeadow Labradors. If the foster family chooses to use their own veterinarian it shall only be by mutual consent and at the foster family expense.
3. Any accidents occurring due to the result of accident or negligence on the part of the foster family or any surgery required due to that negligence shall be at the expense of the foster family.
4. Yearly vaccinations/eye clearances the puppy/dog will be brought to and picked up at Westmeadow Labradors.
5. At two years of age, the dog will be OFA x-rayed. This cost will be borne by Westmeadow Labradors.
6. Feeding costs and normal veterinarian costs shall be borne by the foster family.
7. If Westmeadow chooses to show the dog, it shall be at their expense, and the dog is to be made available for such.
8. If the female clears her certifications, she shall be returned to Westmeadow Labradors in order to be bred and whelp her litter. She will be returned 5 - 6 weeks after whelping. The bitch may average 1 litter per year.
9. The foster family shall notify the breeder each time the female comes into her season.
10. In the case of a male, Westmeadow Labradors will require the male at Westmeadow Labradors whenever a suitable female arrives for breeding.
11. If the dog does not clear its hips or eyes it will be signed over to the foster family at no cost upon proof of spay/neuter. At that time, Westmeadow Labradors relinquishes all rights and financial obligations. The spay or neuter shall be done at Westmeadow Labradors regular veterinarian in Guelph and shall be at the foster family's expense. It is also understood the undersigned puppy/dog shall carry no further guarantees of any type.
12. Westmeadow Labradors will board the dog gratis if space permits. It is understood that as much advance notice as possible shall be given. If circumstances do not allow boarding, then alternative arrangements shall be made and shall be the foster family's responsibility.
13. If at any time the foster family is unable to retain/maintain the dog it will returned to Westmeadow Labradors with no financial remuneration being owed.
14. If it becomes evident that the puppy/dog is not being housed or maintained in its best interests or in accordance with this contract, the dog shall be returned to Westmeadow Labradors with no financial remuneration being paid.
15. If any of these conditions are not met the breeder has the right to have the dog returned to the kennel with no financial remuneration being paid.
16. Should anything occur that the breeders are unable to continue on with the contract, ownership shall be transferred to the foster family after spaying or neutering of the foster dog.
